Dear Leader Schumer:

As leaders of union locals and councils in New York State, we commend you on your steadfast leadership for our country and our great state, particularly in these challenging times. We write to you today about a pension issue that is critical to us, our members, and the communities they serve. The Giving Retirement Options to Workers (GROW) Act would do significant harm to our members' pensions and we urge you to ensure that any future legislative package does not include this anti-worker legislation.

Our members and retirees depend on multiemployer pensions for their families' retirement security. The GROW Act, which was included in the House-passed HEROES bill, is bad for workers, retirees, and unions. This legislation is merely a tool for employers to cut their pension costs and shift all of the risk unto workers and retirees while weakening existing plans at the same time.

The GROW Act changes the law to allow multiemployer pension plans to divert money from an existing plan to create a new composite pension plan. This weakens the existing plan and leaves neither plan—the existing plan, nor the composite plan—with enough money to pay promised benefits for workers and retirees. If Congress had already passed the GROW Act and it was law now, workers in a previously healthy multiemployer pension plan that converted to a composite plan would face draconian benefit cuts.

Composite plans would also make it easier for employers to withdraw from existing multiemployer pension plans without paying their fair share. The GROW Act would eliminate withdrawal liability for composite plans, and it would dramatically reduce the cost of withdrawing from an existing plan. Composite plans would also be exempt from paying Pension Benefit Guaranty Corporation (PBGC) premiums, which would leave workers without protection and contribute to PBGC insolvency.

We urge you to ensure that the GROW Act is not included in any future legislative package. Thank you for considering our views.
