TRUMP SHIPBUILDING CUTS

PUTTING IBEW JOBS, NATIONAL SECURITY AT RISK

The Trump Administration is demanding cuts to the number of ships built by Local 733 members at Huntington Ingalls Shipyard in Pascagoula

- Flight III Arleigh Burke-class Destroyer and America-class Amphibious Assault Ship LHA-9 facing \$650 million cuts
- Trump's budget eliminates **5 of the 13 scheduled destroyers**, reversing 2018 National Defense Authorization Act calling for American fleet increase
- Russian surveillance ship Viktor Leonov came within a few miles of the Florida coast in December 2019, proving the need for more destroyers to protect our coastline.

TRUMP WANTS TO ELIMINATE YOUR UNION

TRUMP SIGNED AN EXECUTIVE ORDER on Feb. 20, 2020 giving the Department of Defense the authority to **abolish** the collective bargaining rights of its **civilian labor unions**.
